PRIVACY POLICY



These terms and conditions ("Terms", "Agreement") are an agreement between Acceso Pa ("APA", "we", "our") and you ("User", "you" or "your"). This term sets forth the general t and conditions of your use of the Montaña Limpia mobile application, its website, its subdomains, applications, programs and other extensions ("App", "Montaña Limpia").

Acceso PanAm respects your privacy. This page is used to inform you regarding our policies with the collection, use, and disclosure of personal information if you decide to use the Montaña Limpia mobile Application ("App"). By accessing the App, you are providing consent to Acceso PanAm's practices described in this Privacy Policy. If you disagree with any of the terms herein, please immediately discontinue use of the App.

About the policy

Montaña Limpia is a free app created by Acceso PanAm. The personal information that we collect is used for providing and improving the service. We will not use or share your information with anyone except as described in this Privacy Policy. The terms used in this Privacy Policy have the same meanings as in our Terms and Conditions, which is accessible at Montaña Limpia unless otherwise defined in this Privacy Policy.

Information Collection and Use

For a better experience, while using our service, we may require you to provide us with certain personally identifiable information, including but not limited to name, e-mail, age range, country. The information will be retained by us and used as described in this Privacy Policy.

The App provides the possibility of logging in with third party services that may collect information used to identify you: [Facebook](#) and [Google](#).

In addition to such information, we also collect information relating to: number of cleanup actions and events ("Cleanups") created by you or in which you participated, quantity and type of trash removed, distance covered. When using the App, we may track and collect App usage data, such as the date and time the App on your device accesses our servers and what information and files have been downloaded to the App based on your device number.

We may collect the physical location of your device by, for example, using satellite, cell phone tower or Wi-Fi signals. We may use your device's physical location to provide you with personalized location-based services and content.

Cookies

Cookies are files with a small amount of data that are commonly used as anonymous unique identifiers. These are sent to your browser from the websites that you visit and are stored on your device's internal memory.

This App uses performance "cookies," which collects anonymous information about how users use the App (such as, for example, Google Analytics). Furthermore, we use a variety of third-party web and mobile App services to improve performance and enhance the visitor experience that may use cookies. You can



choose to accept or decline cookies used by the App. If you decline, you will be able to access most of the App, however, you may not be able to fully use the services offered.

How we disclose and share information

It is our policy not to share, disclose, or sell information to any third party for their promotional use or for marketing purposes. We may disclose and share information we collect as follows:

- To our third-party service providers who provide services such as website hosting, data analysis, information technology and related infrastructure provision, customer service, email delivery, auditing and other similar services.
- By you, through blogs and other services to which you are able to post information and materials, including social media. Please note that any information you post or disclose through these services will become public. We urge you to be very careful when deciding to disclose your Personal Information, or any other information.
- To a third party in the event of any reorganization, merger, sale, joint venture, assignment, transfer, or other disposition of all or any portion of our operations, assets, or stock (including in connection with any bankruptcy or similar proceedings).
- As we believe to be necessary or Appropriate: (a) under Applicable law, including laws outside your country of residence; (b) to comply with legal process; (c) to respond to requests from public and government authorities, including public and government authorities outside your country of residence; (d) to enforce our terms and conditions; (e) to protect our operations or those of any of our affiliates; (f) to protect our rights, privacy, safety or property and/or that of our affiliates, you or others; and (g) to allow us to pursue available remedies or limit the damages that we may sustain.
- We may use and disclose Other Information for any purpose, except where we are required to do otherwise under Applicable law. If we are required to treat Other Information as Personal Information under Applicable law, then we may use it for all the purposes for which we use and disclose Personal Information. In some instances, we may combine Other Information with Personal Information. If we do, we will treat the combined information as Personal Information as long as it is combined.

Security

Acceso PanAm takes all necessary security measures to protect Users' personal data against unauthorized loss, misuse, access, disclosure, alteration or destruction. But remember that no method of transmission over the internet, or method of electronic storage is 100% secure and reliable, and we cannot guarantee its absolute security. Users are also responsible for taking reasonable measures to protect their passwords and usernames, being solely responsible if any unauthorized access has occurred due to carelessness or bad guard procedure. such information.
